The European Community (hereinafter referred to as "the Community"), represented by the Commission of the European Communities (hereinafter referred to as "the Commission"), which is represented for the purposes of the signature of this contract by **Mr Heinz Zourek, Director-General**, Directorate-General for Enterprise and Industry

(hereinafter referred to as "the Contractor"), represented for the purposes of the signature of this contract by **Mr Alain Nandrin, Director General**

HAVE AGREED

ARTICLE III.1 - SUBJECT

III.1.1 This specific contract implements Framework Contract SANCO/2005/A4/05 (LOT 4) signed by the Commission and the Contractor on November 25, 2005 and renewed on 23/11/2007 and 17/11/2008.

III.1.2 This specific contract concerns the **production of 3 video-clips to illustrate three sub-titles of DG ENTR website (machinery, electrical and radio & telecom equipment industries).**

III.1.3 The Contractor undertakes, on the terms set out in the framework contract and in this specific contract and the annex(es) thereto, which form an integral part thereof, to perform the following **tasks specified in Annex I.**

ARTICLE III.2 - DURATION

- III.2.1** This specific contract shall enter into force on the date on which it is signed by the last contracting party.
- III.2.2** The duration of the tasks shall not exceed **28/02/2010**. Execution of the tasks shall start on the date of entry into force of the specific contract. The period of execution of the tasks may be extended only with the express written agreement of the parties before such period elapses.

ARTICLE III - PRICE

- III.3.1** The total amount to be paid by the Commission under this specific contract shall be **101.127,63 €** (*one hundred and one thousand hundred and twenty-seven EURO and sixty-three CENT*) covering all tasks executed.

It should be consisted of :

- **EUR 86.414,55** (*eighty six thousand four hundred fourteen EURO and fifty-five CENT*) covering the tasks described in the technical annex
- A maximum amount of **EUR 13.213,08** (*thirteen thousand two hundred thirteen EURO and eight CENT*) to cover the travel expenses that will be reimbursed according the provisions of the Framework contract.
- A maximum amount of **EUR 1.500** (*one thousand five hundred EURO*) to cover the following variable costs [*Buying of external archives*] upon provision of the relevant justificative documents.


